APPLICATION

TAKE NOTICE that the Plaintiff is applying to the Court for the following orders:

1. Declaring Queensland Police Service, as CRIMINAL ORGANIZATION.

2. Issuing Court recommendation that the people associated with Queensland Police Service are to be sent to re-education facilities where they will be subjected to hard physical labour to instil in them the respect for the laws and other people in the community.

3. Freezing Queensland Police Service bank accounts and all available assets.

4. Selling Queensland Police Service assets, including all the guns, the drums and other toys, if necessary, if the amount in bank accounts is not sufficient to cover my legal Claim.

5. Payment to me, Peter Markan, the amount of A\$ 10 000 000.13 (ten million Australian dollars and thirteen cents) from Queensland Police Service frozen accounts and/or assets.

On 26.05.2014 I lodged in the Supreme Court of Queensland the legitimate Claim against Commissioner Ian Stewart of Queensland Police Service as the commercial organization with ABN 29 409 225 509.

Queensland Police Service is the legally separated entity of the company trading as 'State of Queensland Australia' registered with US Securities and Exchange Commission – 0001244818.

As of today, 30.06.2014, I did not receive the reply from the Defendant who is in breach of rule 137, Time for notice of intention to defend, of Uniform Civil Procedure Rules 1999 and other laws therefore, as the person entitled to the Relief as per my Claim according to law, I am requesting the Court to uphold the law and make the summary judgment against the Defendant.

The conduct of the Defendant is not surprising looking at their history of blatant arrogance and disrespect for the laws, decent behaviour and civil rules in our society.

The unspeakable atrocities committed by that organisation against the society, the culture of committing outrageous, repugnant and illegal acts against the society - makes obvious that for
